3) Authorize the Purchasing Agent, or designee, to execute further documents relating to Agreement for Services 6605, including amendments which do not increase the maximum dollar amount or term

of the Agreement, and contingent upon approval by County Counsel and Risk Management.

DISCUSSION / BACKGROUND

Pro-Line has been providing janitorial services to the County since 2007, including the identified Probation Department (Probation) facilities at Durock Road. The existing agreement with Pro-line expires July 31, 2022.

Under the current recommended Agreement 6605, Pro-Line is contracted to clean Probation located at 3974 Durock Road, Shingle Springs, Suites 205-211; and the Community Corrections Center (CCC) located at 3974 Durock Road, Shingle Springs, Suites 201-204. This agreement includes yearly rate increases. The vendor has indicated it is due to annual wage increases.

ALTERNATIVES

Disapproval of this agreement would require Probation to identify another vendor for janitorial services and develop a contract with that vendor, thereby creating a gap in services.
