Chief Administrative Office recommending the Board approve, and authorize the Chief Administrative Officer to sign, Subrecipient Agreement 6820 with the El Dorado County Water Agency, providing \$5,445,000 in American Rescue Plan Act ("ARPA") funds for the completion of ten water infrastructure projects.

FUNDING: American Rescue Plan Act, State and Local Fiscal Recovery Funds.

DISCUSSION / BACKGROUND

On March 11, 2021, President Biden signed into law the American Rescue Plan Act (ARPA), which allocated \$1.9 trillion to assist in the recovery from the impacts of the COVID-19 pandemic. El Dorado County has received a direct allocation of \$37.46 million. On November 9, 2021 (21-1680), the Board allocated \$6,020,000 in ARPA funds for water infrastructure projects identified as "Tier 1" projects by the El Dorado County Water Agency:

*The South Upper Truckee Erosion Control Project will be completed by the County's Transportation Department. The remaining projects, totaling \$5,445,000 will be administered by the Water Agency, who will further sub-award funds to various implementing agencies.

The Board previously authorized the use of a subrecipient agreement template for use with ARPA funding (Legistar 22-0567, 4/5/22). The recommended Subrecipient Agreement is based on the approved template, and provides that the full \$5,445,000 in funding will be disbursed to the Water Agency upon execution, with regular reporting of use of funds to be provided to the Chief Administrative Office on a quarterly basis.

The Board could direct that a different funding mechanism be utilized.
