DISCUSSION / BACKGROUND:

Health and Human Services Agency (HHSA) oversees the local Foster Care and Adoption programs and helps place children into resource homes. Through collaboration with Lilliput a part of Wayfinder Family Services, Stanford Sierra Youth & Families, Sierra Child and Family Services, and other private, non-profit adoption organizations, HHSA arranges for the permanent adoption of foster children. National Adoption Day is a collective effort to raise awareness of the more than 117,000 children waiting to be adopted from foster care in the United States.

During the period of October 1, 2021, through September 31, 2022, twenty-five (25) children in El Dorado County were successfully placed into prospective adoptive homes and thirty-one (31) children were successfully adopted.
