### DISCUSSION / BACKGROUND

On February 22, 2022, the Board approved Legistar Item #22-0262 regarding Agreement for Legal Services #6362 with Albert Ramseyer, J.D. to provide legal counsel and to provide all customary and usual legal services to represent the Assessor in the Safeway Assessment Appeals Board Matters.

The Safeway Assessment Appeals Board Matter is ongoing. Amendment I would extend the Agreement 5 additional months with a new expiration date of June 30, 2023, and increase compensation by \$25,000 for an amended not-to-exceed amount of \$75,000.

The Board could not extend the contract; however, this would preclude the Assessor from seeking resolution on the matter.
