### Resolution 003-2010

Fiscal Impact/Change to Net County Cost: There is no change in Net County Cost. The attached Resolutions indicate proposed solid waste rate levels.

### Reason for Recommendation:

This item is being brought forth based on a tentative settlement agreement between Waste Connections of California, Inc. and El Dorado County as a result of a lawsuit filed by Waste Connections of California, Inc. arising from the rate setting hearing held on June 23, 2009 (reference item 09-0750).

A public hearing is being conducted for consideration of adjusting the solid waste collection and Material Recovery Facility (MRF) rates for Waste Connections of California, Inc., dba El Dorado Disposal Service by 3.3% effective January 1, 2010.
