Surveyor's Office received an application from Heritage El Dorado Hills Master Association, a California nonprofit mutual benefit corporation for an IOD (IOD 22-0015 B) for Road Right of Way on Assessor's Parcel Number 117-680-001, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This dedication would provide for Road Right of Way on Assessor's Parcel Number 117-680-001.

The offer of dedication shall remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution.
