Transportation Department recommending the Board authorize the Chair to sign the Notice of Acceptance with PBM Construction, Inc. for the El Dorado Trail Improvement Project Forni Road to Missouri Flat Road (JN 71380) in Placerville.

The requested Board action has no associated fiscal impact.

Reason for Recommendation:

The Contract for the El Dorado Trail Improvement Project Forni Road to Missouri Flat Road (Project) in Placerville was approved by the Board on November 18, 2008. The Project was completed on November 21, 2009. Execution of the Notice of Acceptance will start legal time frames for guarantees, a lien period and return of retention monies.

Major Contract Change Orders on this Project dealt with roadway excavation, structural concrete and
