Background: Request to consider Site Plan Review SPR09-0011/Coloma Blues Live! Music Festival submitted by EL DORADO ARTS COUNCIL (Agent: Mary Carrera) for a site plan review to allow a one day music festival with an estimated attendance of 3,000 people and off-site parking. The music festival is proposed for Saturday, June 5, 2010, from 10:00 a.m. to 7:00 p.m. Off-site parking will occur on properties identified by Assessors Parcel Numbers 006-011-75, 006-341-14, and 089-030-23 (The remainder of the parking facilities are on parcels outside of the Countys jurisdiction.). The event site will occur on property identified by Assessors Parcel Number 006-011-42, consisting of 18.69 acres, and is at the Henningson-Lotus County Park located on the northwest side of Lotus Road, approximately three-fourths of a mile south of the intersection with State Highway 49 in the Lotus area, Supervisorial District IV.
