Fiscal Impact/Change to Net County Cost:

No fiscal impact or change to net county cost, the Probation Department has anticipated this revenue in their 2010/11 proposed budget.

Background:

County of El Dorado has two established Juvenile Detention Facilities, Juvenile Hall in Placerville and Juvenile Treatment Center in South Lake Tahoe, for the temporary or long-term commitment of minors detained in accordance with the provisions of the California Welfare and Institutions Code.

Reason for Recommendation:

Pursuant to Board of Supervisors Policy C-1, Contracts with Other Counties, and Policy C-17, Procurement Policy, Section 4.5, Contract Term, "Departments must obtain authorization from the Board of Supervisors, initially, and on an annual basis, to utilize any contract that does not have a stated contract term."

Fully executed agreements are currently in place for the County of Alpine, #440-S0411; County of Amador, #441-S0411; County of Calaveras, #438-S0411; County of Placer, #436-S0411; and County of Plumas, #439-S0411; these agreements do not have a stated contract term. Said Counties place ward(s) of its juvenile court in County of El Dorado Juvenile Detention Facilities on a space available basis at a rate of \$100 per day/per bed. Amador County has a second agreement in place for a two-bed guarantee in the amount of \$100.00 per day per bed, whether or not the bed is occupied, for the placement of juveniles in County of El Dorado Juvenile Detention Facilities.
