Fiscal Impact/Change to Net County Cost: There will be a net county cost decrease as a result of the increased funding received from the Department of Insurance. The original recommended budget represented an allocation of personnel time that can now be increased due to the additional funds resulting in less general fund obligation for the department.

Background: The District Attorney's office has had the Workers Compensation Insurance Fraud grant since fiscal year 04/05. Since taking office in 2007, the District Attorney has increased the amount of funding substantially from prior years due to his committment to investigate and prosecute workers compensation insurance fraud in El Dorado County.

Reason for Recommendation: A signed resolution is required in order for the District Attorney to sign the Grant Award Agreement with the Department of Insurance.
