**Fiscal Impact/Change to Net County Cost:** There is no fiscal impact. Funds are included in the budget and this amendment does not change the total funding amount.

### Background:

On July 1, 2008, the AQMD Board of Directors awarded Funding Agreement (Agreement) No. 010-DMV-08/09-BOS to El Dorado County General Services Department (General Services Department)

in the amount of \$25,000. This funding was to supplement the State Transportation Improvement Program -Transportation Enhancements (STIP-TE) grant of \$295,000, previously awarded to General Services by the El Dorado County Transportation Commission (EDCTC) on February 7, 2008, for engineering and construction of El Dorado Hills SMUD Corridor Class I Bike Path.

On September 29, 2009, the AQMD Board of Directors approved Amendment I to the Agreement, which replaced all references to General Services Department with references to DOT and extended the project completion date by twelve (12) months to December 31, 2010.

The proposed Amendment II extends the project completion date by another twelve (12) months to December 31, 2011. This extension will allow DOT Facilities Engineering Division to complete the preliminary engineering and environmental phase for this project, which was temporarily put on hold due to limited staff resources and other projects with higher priorities.

**Reason for Recommendation:**

Approval of this project will help reduce vehicular traffic and associated mobile sources emissions by providing a safe shortcut for bicyclists and pedestrians between El Dorado Hills Blvd and Silva Valley Parkway. The total funding award remains unchanged.

Forward executed amendment to AQMD for further processing.
