- 2) Approve Ordinance OR10-0002 amending Chapter 17.14 (Miscellaneous Development Requirements) to add the Wind Energy Conversion Systems Ordinance as Section 17.14.240 of the Zoning Ordinance, as shown in Exhibit A, based on the Findings listed in Attachment 1; and 3) Adopt said Ordinance. Background: Request to consider OR10-0002/Wind Energy Conversion Systems initiated by EL DORADO COUNTY. Proposed amendment to County Ordinance, Title 17, to add provisions for wind energy conversion systems to comply with California Government Code Section 65893 which encourages local agencies to adopt zoning standards that enable construction of small wind energy conversion systems for on-site home, farm, and small commercial use. The intent is to provide standards and regulations for the safe and effective construction and use of these systems, as well as for larger, utility-scale systems that can potentially be developed within the County, based on the State Energy Commissions *Wind Resource Potential Maps*.
