**Background:** The Department of Resources Recycling and Recovery (CalRecycle) has allocated Statewide two million two hundred thousand dollars (\$2,200,000) for the Local Government Waste Tire Cleanup and Amnesty Event Grant Program in fiscal year (FY) 2010-11.

**Reason for Recommendation:** This grant is to help divert waste tires from landfill disposal, prevent illegal tire dumping, and educate the public about waste tire recycling and proper tire maintenance. An Amnesty Day Event allows private citizens to take waste tires, in non-commercial quantities, to a specific location established by the local government administering the grant program.

The Environmental Management Department has traditionally been successful in receiving and implementing this grant program.
