Fiscal Impact/Change to Net County Cost: None. This is a nonfinancial MOU.

Termination: MOU includes the County's standard Fiscal Considerations termination language, as well as a provision for the County to terminate the MOU without cause in seven (7) calendar days upon written notice.

Reason For Recommendation: The Sacramento Area Council of Governments (SACOG) is an association of local governments in the six-county Sacramento region. SACOG provides transportation planning and funding for the Sacramento region and serves as a forum for the study and resolution of regional issues. Its members include the counties of El Dorado, Placer, Sacramento, Sutter, Yolo and Yuba as well as 22 cities located within these six counties. Supervisor John Knight is the County of El Dorado's SACOG representative and currently serves on their Board. The City of Placerville is the only member city from the County of El Dorado and its mayor, Pierre Rivas, also currently serves on the SACOG Board.

Memorandum of Understanding 173-M1111 allows the Department of Human Services (DHS) to provide confidential CalWORKS and General Assistance beneficiary location data to SACOG for performing a Lifeline Transportation Study in an effort to improve the public transportation of low-income individuals to essential destinations such as medical care and other medical facilities. SACOG has a similar MOU in place with its other member counties. The MOU becomes effective upon execution, remains in effect for one year and automatically renews for successive one-year terms unless terminated pursuant to the terms and conditions contained therein. It includes the County's standard "fiscal out" termination clause, as well as a provision for the County to terminate the MOU in seven (7) calendar days upon written notice.

Action To Be Taken Following Board Approval:

- 1) Chair to sign two (2) originals of MOU 173-M1111.
- 2) Board Clerk's Office to return one (1) original MOU to DHS at Briw Road.
- 3) Department to distribute as appropriate.
