Background: At the request of the Department of Transportation, the Procurement and Contracts Division issued Invitation to Bid # 09-760-111 for the purchase of Cutting Edges used for snow removal and grading equipment. The Purchasing Agent awarded Bid #09-760-111 to the low qualified bidder Holt of California, for a twelve month period ending June 15, 2011. In June 2009, two

purchase orders were issued for an amount totaling \$48,565.54. In March 2010, Holt of California agreed to extend the Bid with the same pricing, terms and conditions as the original bid. A new Blanket Purchase Order (BP20100832) was issued for the extended period through June 15, 2011. One purchase of cutting edges totaling \$29,642.69 was made in September of 2010.

Reason for Recommendation: Prices are expected to rise for cutting edges in the coming year. the Department of Transportation would like to take advantage of the 2009 prices on the current bid and make one more purchase of cutting edges before the bid expires in June of this year. The vendor has shown willingness to hold the 2009 pricing. On the proposed purchases of \$62,720.49, the expected savings using 2009 pricing compared to current prices will be just over \$10,000.00. The proposed purchase will satisfy the requirements for cutting edges through the end of the fiscal year 2012.

The cumulative purchases of cutting edges including the proposed purchase will equal \$140,928.72 an amount that exceeds the Purchasing Agents signature authority, therefore approval to make this additional purchase of cutting edges requires Board of supervisors approval.

FISCAL IMPACT/CHANGE TO NET COUNTY COST: Procurement and Contracts has been advised that funding is available within the Department of Transportation's budget. Non-General Fund- Road Fund Discretionary.

ACTION TO BE TAKEN FOLLOWING APPROVAL: Following Board approval, the Procurement and Contracts Division will increase the blanket purchase order by \$41,428.72 for a twelve month term. Contact: Eric van Leeuwen, Buyer II x5834
