Fiscal Impact/Change to Net County Cost:

No change. The amount payable by the State to the County of El Dorado under this Agreement is \$257,100 with no match requirement. This funding is included in the Department's FY 2011-12 Recommended Budget.

Reason for Recommendation:

Agreement MS-1112-35 provides \$257,100 in Federal and State funding to provide the Multipurpose Senior Services Program in the County of El Dorado during FY 2011-12. MSSP provides care management, which consists of providing information and assistance regarding appropriate community resources to meet needs, as well as monitor on-going care and health status. These services assist Medi-Cal eligible, frail, vulnerable seniors to remain in their homes and independent to the extent possible.
