Background: Request to consider Rezone Z09-0009/Parcel Map P09-0013 submitted by ANTHONY P. DEVILLE, SR. and LINDA DEVILLE (Agent: C.J. Smith, III) to rezone from Estate Residential (RE-10) to Estate Residential Five-Acre (RE-5); and Tentative Parcel Map to create two parcels, each five acres in size. The property, identified by Assessor's Parcel Number 070-131-07, consisting of 10.3 acres, is located on the west side of Sierra Vista Road, approximately 1.2 miles south of the intersection with Green Valley Road, in the Rescue area, Supervisorial District 4. *[Project Planner: Tom Dougherty]* (Negative declaration prepared)
