Background: Request to consider Rezone Z09-0010/Parcel Map P09-0014 submitted by ANTHONY P. DEVILLE, JR. and SHARON DEVILLE (Agent: C.J. Smith, III) to rezone from Estate Residential (RE-10) to Estate Residential Five-Acre (RE-5); Tentative Parcel Map to create two parcels, each five acres in size; and a Design Waiver request to allow a driveway to access Parcel A. The property, identified by Assessor's Parcel Number 070-131-16, consisting of 10.01 acres, is located on the west side of Sierra Vista Road, approximately 1.2 miles south of the intersection with Green Valley Road,
