Clerk of the Board, based upon the recommendation of the First 5 El Dorado Children and Families Commission, recommending the Board;

1) Make the following appointments to the First 5 El Dorado Children and Families Commission: Appoint Sabrina Owens, County Public Health/Behavioral Health Member, Term Expiration 05/31/2020:

Appoint Ginger Swigart, Community Representative, Term Expiration 05/31/2017 <u>2020</u>; and Reappoint Constance Zelinsky, Community Representative, Term Expiration 05/31/2017 <u>2020</u>;

- 2) Receive and file a Community Hub presentation from Kathleen Guerrero, Director; and
- 3) Adopt an update to First 5 El Dorado Children and Families 2016-2021 Strategic Plan pursuant to county ordinance code section 2.20.950(F). (Est. Time: 30 Min.)

A Notice of Vacancy was posted for the Community Representative appointments. First 5 El Dorado Children and Families Executive Director worked with the Health and Human Services agency regarding the appointment of a County Public Health/Behavioral Health Member as this is a very specific appointment. A recommendation was received from the First 5 El Dorado Children and Families Commission by the Clerk of the Board on May 1, 2017 to make the above mentioned appointments.

El Dorado County Ordinance Code reference:

Sec. 2.20.950. - County strategic plan.

The Commission shall adopt an adequate and complete strategic plan for the support and improvement of early childhood development within the County.

- A. The plan shall be consistent with, and in furtherance of the purposes of, the Act and any guidelines adopted by the State Commission pursuant to Subdivision (b) of Section 130125 that are in effect at the time the plan is adopted.
- B. The plan shall, at a minimum, include the following: a description of the goals and objectives proposed to be attained; a description of the programs, services and projects proposed to be provided, sponsored, or facilitated; and a description of how measurable outcomes of such programs, services and projects relating to early childhood development within the County will be integrated into a consumer-oriented and easily accessible system.
- C. The Commission shall measure the outcomes of its funded programs through the use of applicable, reliable indicators and review that information on a periodic basis as part of the public

review of its County strategic plan.

- D. The Commission shall conduct at least one public hearing on the proposed County strategic plan prior to the adoption of the plan and any subsequent revisions to the plan.
- E. The Commission shall, on at least an annual basis, review the plan and revise the plan as may be necessary and appropriate.
- F. The proposed plan, and any subsequent revisions to the plan, shall be submitted to the Board of Supervisors for approval, prior to submission to the State Commission.
- G. The Commission shall submit its adopted strategic plan and any subsequent revision thereto, to the State Commission.
