Surveyor's Office recommending the Board:

 Acknowledge and consent to the making of an Irrevocable Offer of Dedication for a Drainage Easement on Assessor's Parcel Number 120-720-004, located in El Dorado Hills, District 1;
Authorize the Chair to sign the Consent to the Making of an Irrevocable Offer of Dedication for a Drainage Easement;

 3) Acknowledge an Irrevocable Offer of Dedication for a Drainage Easement on behalf of those public entities that will provide services, subject to the purveyor's construction standards; and
4) Authorize the Chair to sign the Consent to the Making of an Irrevocable Offer of Dedication for the Drainage Easement and to record the Irrevocable Offer of Dedication with the Consent attached, pursuant to Government Code Section 7050.

#### FUNDING: Application Fees. (General Fund) DISCUSSION / BACKGROUND

Surveyor's Office received an application from Treviso Ridgeview 7, LLC, a California Limited Liability Company, for an Irrevocable Offer of Dedication (IOD 20-0003) for a Drainage Easement on Assessor's Parcel Number 120-720-004, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This dedication would provide for a future drainage easement on Assessor's Parcel Number 120-720-004.

# ALTERNATIVES

An alternative would be to not accept the IOD. By utilizing this alternative, no provision would be made for a future Drainage Easement on Assessor's Parcel Number 120-720-004.
