At these events, STR staff and CCAC fellows led lessons about waste sorting, recycling, and the impacts of methane production from organic disposal in landfills.

The west slope was assisted by BREATHE California. They on-boarded 10 schools to organics recycling and built partnerships for edible food recovery. Providing hands on training for educators, staff, and students. BREATHE outreached to every school in the County offering services at no cost.

El Dorado Disposal also accepts e-waste at Cameron Park, El Dorado Hills, and Placerville recycling centers (TVs over 60" must go to main MRF). County temporary household hazardous waste events accept electronic waste. Community clean-up events accept e-waste. Materials collected: Televisions, computer monitors and towers, small electronics, batteries, and other electronic devices. TTSD offers curbside collection for small electronics (under 6x8x10 inches) and batteries in plastic bags on trash can lids.
